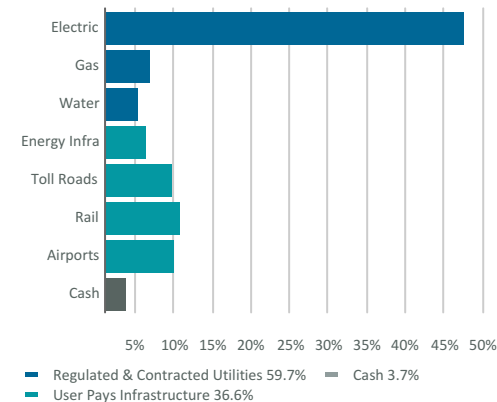

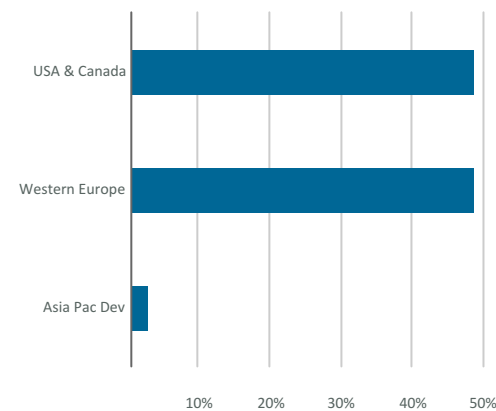

REGIONAL BREAKDOWN

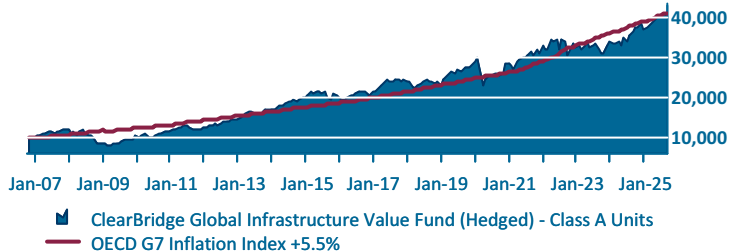

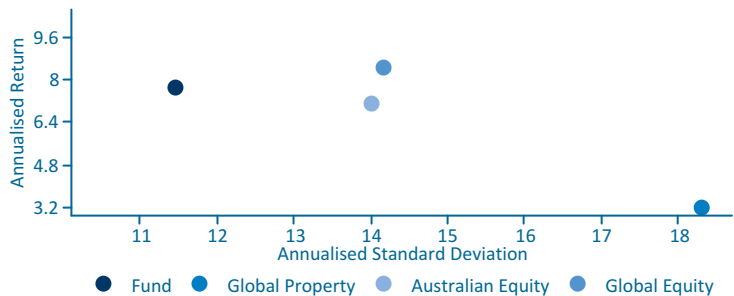
