

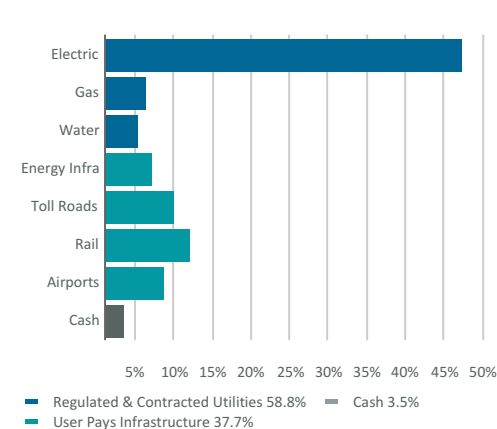
ClearBridge Global Infrastructure Value Fund (Hedged) - Class A Units

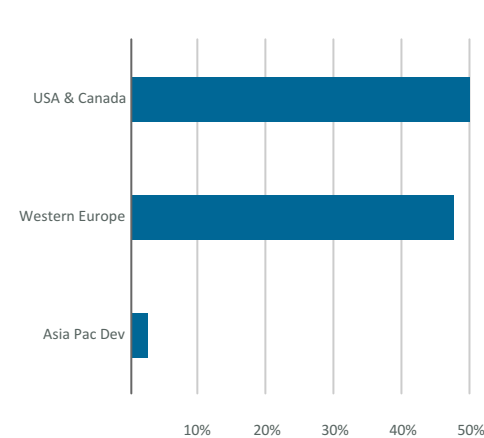

REGIONAL BREAKDOWN



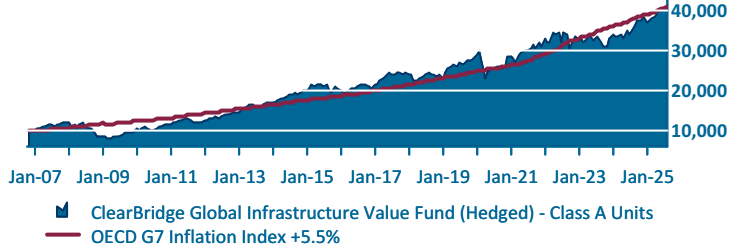

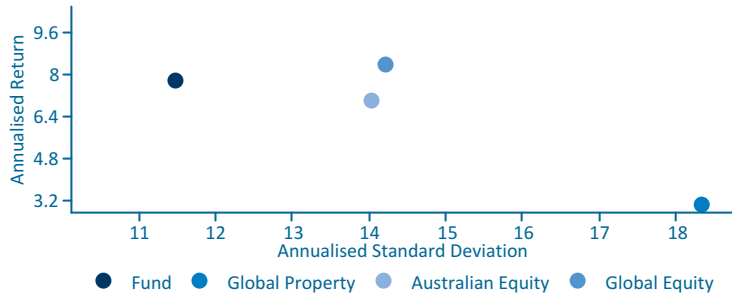
