

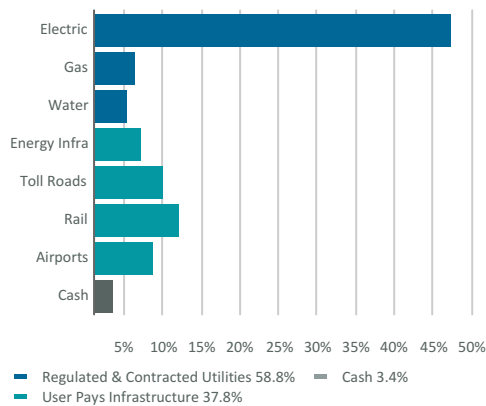
ClearBridge Global Infrastructure Value Fund - Class A Units

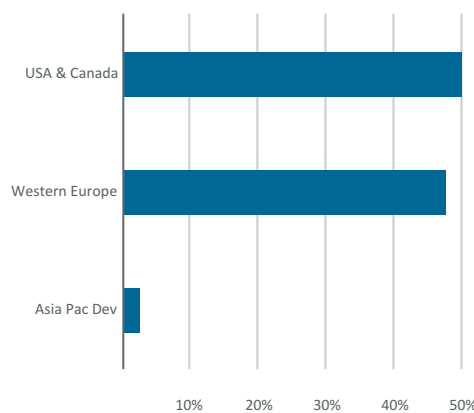

REGIONAL BREAKDOWN



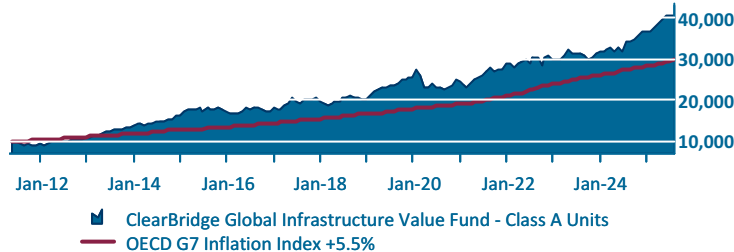

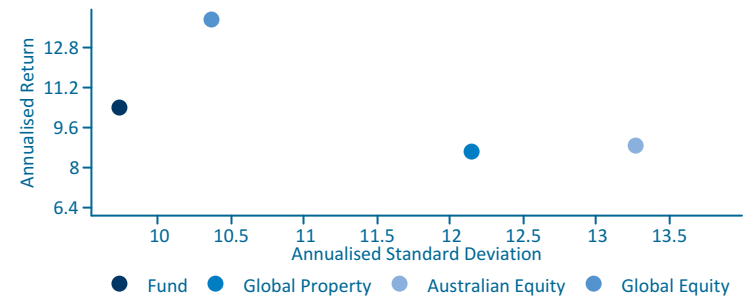
